# **Privacy Statement Summary:**

Who will use my data?	Escort Centre and Clients	
What for?	As a user of our site we will store and process your data in order to allow us to provide our companionship and escort services to you. We will store and process your data in order to manage your booking and process payment. This may include sensitive personal information as required to fulfil your request.	
	As a member of our gallery we will store your information; including sensitive, personal information, in order to promote you on our site and generate bookings for companionship and escort services.	
What will happen if I contact you?	If you contact us as a client we will use your information to manage your booking, take payment and fulfil your request.	
	If you contact us as a potential member of our gallery we will store and process your information in order to complete ID checks and provide our escort introduction services to you. If we mutually agree to feature you on our site we will store your details in order to maintain our relationship, manage payments and provide our introduction services to you.	
What data will be stored?	As a client, we will store your personal details in order to provide our services to you, this may include sensitive personal data and financial data. We will store details of bookings/booking enquiries, and related financial information as required. We will only store this data with your explicit consent.	
	As a member of our site, we will store your personal details which have been provided to us via our site, email, instant messaging services, or by any other means during the recruitment process, or provided when registering you as a member of the site. This may include sensitive personal data and financial data which we will only collect with your explicit consent.	
What data will be shared?	We will not share your data with any third parties other than as described in this document. We may however share your information (after conducting appropriate checks) with any regulator or legal body that legally requests it.	
How long?	Your data will only be stored for as long as required, after which time the information will be deleted. As a client your details will only be stored for as long as required to complete the booking and any associated financial transactions.	
	As a member of this site we may store your details for up to 7 years after which time your data will be deleted.	
Who can access my data?	We will never sell, share or otherwise distribute your data to any third party; other than as required to operate our business and provide our services to you.	
How is my data kept secure?	We will store your data on secure UK based servers which will be processed in the UK. We use appropriate security protocols/technology to secure data.	

# **About This Privacy Policy**

This policy sets out how we will use and share the information that you give us. This policy describes your relationship with Escort Centre. The Data Protection Act 1998 (DPA) and General Data Protection Regulation (GDPR) describes how organisations must collect, handle, process and store personal information. These rules apply regardless of whether data is stored electronically, on paper or on other materials.

To comply with the law, personal information must be collected and used fairly, stored safely and not disclosed unlawfully. GDPR is underpinned by eight important principals. These say that personal data must:

GDPR is underpinned by eight important principals. Personal data must:

- Be processed fairly and lawfully
- Be obtained only for specific, lawful purposes
- Be adequate, relevant and not excessive
- Be accurate and kept up to date
- Not be held for any longer than is necessary
- Processed in accordance with the rights of the data subjects
- Be protected in appropriate ways
- Not be transferred outside the European Economic Area, unless that country or territory also ensures an adequate level of protection

We take these responsibilities seriously and will always act with complete discretion processing your data as confidential information. This document describes our approach to data protection. This policy helps to protect us from data security risks, including:

- Breaches of confidentiality. For instance, information being given out inappropriately
- Failing to offer choice. For instance, all individuals should be free to choose how the company uses data relating to them
- Reputational damage. For instance, the company could suffer if hackers successfully gained access to sensitive data

#### **Scope of Agreement**

By submitting your personal data on this site or by any other route, you are affirming your agreement for such information to be used in accordance with this privacy policy. You will be able to change your preferences at any time by the methods described as prescribed in this document.

# **Our obligations**

We are a data controller. In relation to the information that you provide to us, we are legally responsible for how that information is handled. We will comply with the GDPR (2018) in the way we use and share your personal data. Among other things, this means that we will only use your personal data:

- Fairly and lawfully
- As set out in the legislation and this policy
- To the extent necessary for these purposes
- We will take steps to ensure your data is accurate and rectify data as necessary


Under certain circumstances, you have rights under data protection laws in relation to your personal data. These include the right to:

- Request access to your personal data
- Request correction of your personal data
- Request erasure of your personal data
- Object to processing of your personal data
- Request restriction of processing your personal data
- Reguest transfer of your personal data
- Right to withdraw consent

You will not usually have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we may refuse to comply with your request in these circumstances.

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

We try to respond to all legitimate requests within one month. Occasionally it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

### Who this privacy policy applies to

Escort Centre is an escort and companionship agency. This policy relates to users of Escort Centre either as a client, as a member of our gallery, or in any other capacity. Processing of your data is required in order to offer you our services. This policy applies to all data that the company holds relating to identifiable individuals, even if that information technically falls outside of the DPA and GDPR. This can include:

- Names of Individuals
- Home or other addresses
- Email addresses
- Social media / IM identifiers
- Telephone/mobile numbers
- Sensitive personal information
- Any other information relating to individuals

### What this policy applies to


This section describes the lawful basis for processing your data and applies to the information about yourself that you choose to provide us with or that you allow us to collect. For clients, this includes:

- Information you provide to us in the following ways our online contact form, by email, phone, social media, IM or by any other means
- When you contact us in order to discuss using our services in any way
- Information we collect showing how you use the website
- Information relating to escort services we offer to you and other personal information required to provide these services
- Information given and stored as part of our ongoing relationship, including financial information
- Sensitive, personal information you provide as part of any communication/request

#### How your information will be used

As a client or member of our gallery, we will only use your personal data (where there is a lawful basis for such processing) for the purposes for which we collected it and as you would

reasonably expect your data to be processed. For example:

As a client we may collect and process information about you, including your name, address, contact details (including email address and phone number), and sensitive, personal information about your requirements in order to provide our services to you. For example

- To respond to queries from you regarding availability, costs, and services
- To carry out our checks, possibly including ID verification and financial checks
- To manage and administer the relationships between you and us
- To notify you about changes to our services and to otherwise communicate with you

As a member of our gallery, the data we receive from you will only be used for the purposes it was provided for, including:

- To respond to queries from you regarding the possible inclusion in our escort and companionship gallery
- To carry out our checks including ID checks
- To manage and administer the relationships between you and us
- To notify you about changes to our services and to otherwise communicate with you

• We will use your contact details in order to respond to any queries that our clients submit to us about your availability, services, charges and so on.

### How to change your preferences

We operate in line with EU GDPR (May 2018) data protection guidelines. We respect your rights and will respond to any request for access to personal information and requests to delete, rectify, transfer data and to stop processing. We will also advise you on how to complain to the relevant authorities, namely the Information Commissioner's Office. Any requests or objections should be made in writing to the Data Controller. You can visit our website, call, or email us to change your preferences at anytime.

### Opting out at a later date

Where you give your agreement for us to process your data, you can contact us to amend or withdraw your agreement at anytime. You can also choose to object to processing and request deletion of your data with limitation. We respect all user rights as defined in GDPR. If you have any comments or wish to complain please contact us. Where we collect sensitive personal data we will always ask for your explicit consent, you can withdraw your consent at anytime by contacting us using the details shown.

### How we store and process your data

Your data will be collected, stored and processed in the UK only. We do not knowingly transfer your data outside the EU. Your data will only be stored as long as required to provide our services to you, either as a client or as a member of our gallery. We will ensure all data is securely deleted in line with our strict Data Retention and Erasure Policy.

In order to provide our services to you, we use recognised third parties to take payment, manage our company accounts and provide banking services. We will store transactions, payments and order data for up to 7 years (or for as long as required by UK financial and company regulations). These third parties may operate outside the EU, if this is the case we will ensure precautions are in place to protect your data.

We will only use your personal data for the purposes for which we collected it. We may be legally obliged to disclose your personal information without your knowledge to the extent that we are required to do so by law; in connection with any ongoing or prospective legal proceedings; in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk); to any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information.

#### **Third Parties**

We may have to share your personal data with the parties set out below for the purposes described in this document:

- Service providers who provide IT and system administration services
- Professional advisers including lawyers, bankers, auditors and insurers who provide consultancy, credit scoring, banking, legal, fraud protection, insurance and accounting services
- HM Revenue & Customs, regulators and other authorities based in the United Kingdom and other relevant jurisdictions who require reporting of processing activities in certain circumstances
- Third parties to whom we sell, transfer or merge parts of our business or our assets

We require all third parties to whom we transfer your data to respect the security of your personal data and to treat it in accordance with the law. We only allow such third parties to process your personal data for specified purposes and in accordance with our instructions.

As an escort and member of our gallery your image, details, and sensitive personal information will be available online across a wide range of sites and on all available devices. We do not limit promotion of any content and as such your data may be available outside the EU. This is beyond our control and as such not covered by this policy.

### **Security**

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know such data. They will only process your personal data on our instructions and they are subject to a duty of confidentiality. We will report any breaches or potential breaches to the appropriate authorities within 24 hours and to anyone affected by a breach within 72 hours. If you have any queries or concerns about your data usage, please contact us.

This website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy notice of every website you visit.

#### Cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes, by gathering and remembering information about your preferences. We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analytical purposes and then the data is removed from the system.

Overall, cookies help us to provide you with a better website by enabling us to monitor which

pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. However, this may prevent you from taking full advantage of the website.

As well as your ability to accept or reject cookies, we also require your permission to store cookies on your machine. That is why when you visit our site you are presented with the ability to accept our terms of use, including the storage of cookies on your machine. Should you not accept then you are free to leave our website, at any time.

### Contacting us, exercising your information rights and Complaints

If you any questions or comments about this Privacy Policy, wish to exercise your information rights in connection with the personal data you have shared with us or wish to complain, please contact Escort Centre using any of the provided contact information. We will process SARs within 20 days, SAR responses are usually free but we reserve the right to charge for excessive or unfounded requests. We fully comply with Data Protection legislation and will assist in any investigation or request made by the appropriate authorities.
